Eligibility

1. Age: Queen must be a young lady between 16 and 23 years of age. Princess must be a young lady between 12 and 15 years of age as of September 1, 2011.
2. Education: If school age, must be currently enrolled and attending Junior High School, High School or GED program with passing grades.
3. Must be single, never married and without children.
4. Contestant shall not have been convicted of a felony.
5. Must be physically able to perform duties of Queen or Princess.
6. Must have access to a horse and horse trailer.
7. Must have proof of age.
8. Must be a Mohave County resident.
9. Must be available for judging September 10th, available for pictures, practices and meetings August 3th - September 9th and available for the Rodeo events September 23rd, 24th and 25th.
10. Entries close August 1st.

Rules and Regulations

1. Contestants shall conduct themselves in a proper manner and portray high moral standards.
2. Contestants shall not be permitted to consume alcoholic beverages or illegal drugs, smoke or use offensive language any time during the competition and/or while representing Kingman and The Andy Devine Days Rodeo.
3. Horses shall not be shared during horsemanship competition. Contestants must use one horse once the horsemanship competition begins; the same horse for all phases of the horsemanship competition.
4. Any attempt to persuade, influence or harass any of the judges or any other contestants at any time shall result in disqualification of the contestant involved, whether or not the act or acts were committed by the contestant, relative parent, friend or associate.

5. Any contestant in violation of any one or more of these rules and regulations shall be subject to disqualification and the decision of the Kingman Rodeo Queen Committee (the "Committee") SHALL BE FINAL.
6. If chosen, the Queen is required to attend a minimum of five (5) rodeos during the year after being named Queen. Those rodeos include PRCA Rodeos in Scottsdale, Prescott, Yuma Arizona and Laughlin Nevada.

The Queen and/or Princess shall also be required to represent the Andy Devine Days Rodeo at such events in Mohave County, Arizona, as may be reasonably requested by the Committee. IF THE QUEEN IS UNABLE OR UNWILLING TO PERFORM HER OBLIGATIONS UNDER THESE RULES AND REGULATIONS, THE QUEEN SHALL UPON REQUEST OF THE COMMITTEE RETURN ALL PRIZES AND AWARDS TO THE KINGSMEN, INC., AND THE RUNNER UP SELECTED IN THE QUEEN CONTEST SHALL ASSUME THE QUEEN'S TITLE AND RESPONSIBILITIES.

7. Except for any stipend donated by the Kingsmen, the Queen shall pay for all expenses incurred in attending the rodeos required under these rules and regulations and shall not be entitled to any reimbursement for such costs or any commission or compensation for fulfilling her obligations as Queen. Notwithstanding the foregoing the Queen may solicit donations to defray the expense of attending the required rodeos.
8. The selected Queen or Princess shall not appear at any activity or event on behalf of the Kingman Andy Devine Days Rodeo without prior approval of the Committee.
9. At all times while participating in any scheduled activities, contestants shall abide by the supervision of the Committee.
10. At all official appearances and events, when appearing on behalf of the Kingman Andy Devine Days Rodeo, the Queen shall wear appropriate western clothing, the Queen's sash and Queen's crown, and provide her own horse.
